

# STATLINE SPORTS CLUB

## Terms of Service

Effective Date: March 19, 2026

Operated by Dagostino Enterprise | Wyoming

*PLEASE READ THESE TERMS OF SERVICE CAREFULLY BEFORE USING THE STATLINE SPORTS CLUB PLATFORM. BY ACCESSING OR USING THE PLATFORM, YOU AGREE TO BE BOUND BY THESE TERMS. IF YOU DO NOT AGREE, DO NOT USE THE PLATFORM.*

## 1. Acceptance of Terms

---

These Terms of Service ("Terms") constitute a legally binding agreement between you ("User," "you," or "your") and Dagostino Enterprise ("Company," "we," "us," or "our"), the operator of Statline Sports Club ("Platform"). By creating an account, accessing, or using the Platform in any manner, you acknowledge that you have read, understood, and agree to be bound by these Terms, along with our Privacy Policy, which is incorporated herein by reference.

## 2. Description of Service

---

Statline Sports Club is a skill-based competitive prediction league platform. Users compete against other participants by submitting spread-based picks on sporting events over a defined contest period. Points accumulate based on pick accuracy. Fixed prizes are awarded to top-finishing participants at the conclusion of each contest period.

The Platform operates as follows:

- Users select from available spread-based picks on sporting events each day
- Points are accumulated over a 30-day contest period across all daily picks
- Participants compete on a peer-to-peer leaderboard against other users in their group
- Fixed prizes, announced in advance, are awarded to top finishers at month end
- The Company does not take opposing positions on any pick or outcome
- Daily prize awards may be available at the Company's discretion

*Statline Sports Club is a skill-based contest platform. It is not a sportsbook, gambling operator, or wagering service. The monthly entry fee constitutes a tournament participation fee, not a wager on any individual sporting outcome.*

## 3. Eligibility

---

### 3.1 Age Requirements

You must meet the following minimum age requirements to participate in paid contests:

- 18 years of age or older in all eligible states
- 19 years of age or older in Nebraska

Free-to-play features may be available to users under these age thresholds at the Company's sole discretion, subject to applicable law.

### 3.2 Geographic Eligibility

Paid contest participation is available only to users physically located in eligible states at the time of contest entry. Eligible states are determined by the Company based on applicable law and are subject to change. It is your responsibility to ensure you are physically located in an eligible state when entering a paid contest.

Paid contest entry is expressly prohibited for users physically located in states where such contests are not permitted, including but not limited to: Florida, New York, Washington, Arizona, Michigan, Ohio, Pennsylvania, Louisiana, and Utah. This list is not exhaustive. The Platform's geofencing systems will restrict access accordingly.

### 3.3 One Account Per User

You may maintain only one account on the Platform. Creating multiple accounts to circumvent restrictions, gain competitive advantage, or manipulate contest outcomes is strictly prohibited and will result in immediate account termination and forfeiture of all prizes and entry fees.

### 3.4 Employees and Affiliates

Employees, contractors, officers, directors, and immediate family members of Dagostino Enterprise are not eligible to participate in paid contests.

## 4. Account Registration and Security

---

To access paid contest features, you must create an account and complete identity verification. You agree to:

- Provide accurate, current, and complete information during registration
- Maintain and promptly update your account information
- Keep your password confidential and not share account access with any third party
- Notify the Company immediately of any unauthorized account access
- Accept responsibility for all activity that occurs under your account

The Company reserves the right to suspend or terminate accounts containing inaccurate, fraudulent, or incomplete information.

## 5. Identity Verification (KYC)

---

Prior to entering any paid contest, you are required to complete identity verification. This process requires submission of:

- Legal full name
- Date of birth
- Current residential address
- Last four digits of Social Security Number
- Government-issued photo identification (where required)

Identity verification is conducted by a third-party service provider. The Company's obligation is to conduct verification in good faith. The Company is not liable for fraudulent use of another person's identity by a third party. Failure to complete verification will result in inability to enter paid contests or receive prize disbursements.

## 6. Entry Fees and Payment

---

Paid contest entry fees are collected at the time of contest registration. By submitting an entry fee, you authorize the Company to charge the designated amount to your selected payment method. All entry fees are in U.S. dollars.

Entry fees are non-refundable except in the following circumstances:

- The contest is cancelled by the Company prior to commencement
- A verified technical failure prevented your participation through no fault of your own
- Required by applicable law

The Company retains a platform fee (rake) from each contest group's total entry fees. The remaining balance constitutes the prize pool distributed to eligible winners. The rake percentage and prize structure for each contest tier are disclosed at the time of entry.

## 7. Contest Rules

---

### 7.1 Pick Submission

Users must submit their daily picks prior to the designated lock time for each slate of games. Picks submitted after lock time will not be accepted. It is the user's responsibility to submit picks on time. No exceptions will be made for missed submissions due to user error, device failure, or connectivity issues.

### 7.2 Postponed and Cancelled Games

In the event a game is postponed, cancelled, or otherwise not completed, the affected picks will be voided and will not count toward or against the user's daily record. The Company reserves the right to substitute alternative picks or adjust daily pick counts at its discretion.

### **7.3 Scoring**

Points are awarded based on pick accuracy as determined by official game results and applicable spreads. The Company's scoring determination is final. In the event of a data error or feed discrepancy, the Company reserves the right to correct scores and standings at any time.

### **7.4 Leaderboard and Standings**

Daily standings reflect same-day pick performance and reset at 3:00 AM Eastern Time following completion of all games in that slate. Monthly standings reflect cumulative point totals for the 30-day contest period and do not reset. Monthly standings determine prize eligibility.

### **7.5 Group Capacity**

Each contest group has a maximum capacity of 50 participants. A new group will not open until the preceding group has reached capacity. The Company does not guarantee minimum group sizes.

## **8. Prizes**

---

### **8.1 Prize Structure**

Prize structures for each contest tier are fixed and disclosed prior to entry. Prizes do not scale with the number of entries or total entry fee volume collected. Prize eligibility is determined by final monthly leaderboard standing at the conclusion of the 30-day contest period.

### **8.2 Prize Disbursement**

Prizes will be disbursed within a reasonable time following contest conclusion, subject to identity verification and tax documentation requirements. The Company reserves the right to withhold prize disbursement pending completion of required documentation.

### **8.3 Tax Obligations**

Users who receive prizes of \$600 or more in a calendar year will be required to complete IRS Form W-9 prior to prize disbursement. The Company will issue IRS Form 1099-MISC to applicable winners and file with the Internal Revenue Service as required by law. You are solely responsible for all federal, state, and local taxes on prizes received.

### **8.4 Forfeiture**

Prizes may be forfeited in the event of: account termination for violation of these Terms, failure to complete required identity verification or tax documentation within 30 days of contest conclusion, or discovery of fraudulent activity associated with the account.

## **9. Prohibited Conduct**

---

The following conduct is strictly prohibited and will result in immediate account termination and forfeiture of all prizes and entry fees:

- Creating or using multiple accounts
- Using automated scripts, bots, or software to submit picks or interact with the Platform
- Colluding with other users to manipulate contest outcomes or leaderboard standings
- Exploiting technical errors, bugs, or vulnerabilities in the Platform
- Providing false or fraudulent information during registration or verification
- Accessing the Platform from a geographically restricted location using VPN, proxy, or other circumvention tools
- Sharing account credentials or allowing third parties to participate under your account
- Engaging in any conduct that disrupts or interferes with the Platform or other users' experience

## 10. Intellectual Property

---

All content, features, functionality, branding, and technology comprising the Statline Sports Club Platform are the exclusive property of Dagostino Enterprise and are protected by applicable intellectual property laws. You are granted a limited, non-exclusive, non-transferable license to access and use the Platform for personal, non-commercial purposes in accordance with these Terms.

You may not reproduce, distribute, modify, create derivative works of, publicly display, or exploit any portion of the Platform without express written permission from the Company.

## 11. Privacy

---

Your use of the Platform is subject to the Company's Privacy Policy, available at [info@statlinesportsclub.com](mailto:info@statlinesportsclub.com). By using the Platform, you consent to the collection, use, and disclosure of your information as described in the Privacy Policy. The Company collects identity verification information, payment information, and usage data as necessary to operate the Platform and comply with applicable law.

## 12. Disclaimers

---

THE PLATFORM IS PROVIDED "AS IS" AND "AS AVAILABLE" WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED. DAGOSTINO ENTERPRISE EXPRESSLY DISCLAIMS ALL WARRANTIES INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT.

The Company does not warrant that the Platform will be uninterrupted, error-free, or free of viruses or other harmful components. The Company does not warrant the accuracy of sporting event data, scores, or results provided through third-party data feeds.

## 13. Limitation of Liability

---

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, DAGOSTINO ENTERPRISE SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES ARISING OUT OF OR RELATING TO YOUR USE OF THE PLATFORM, INCLUDING BUT NOT LIMITED TO LOSS OF PROFITS, LOSS OF DATA, OR LOSS OF ENTRY FEES, EVEN IF THE COMPANY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

The Company's total liability to you for any claim arising out of or relating to these Terms or the Platform shall not exceed the total entry fees paid by you in the three months preceding the claim.

## 14. Indemnification

---

You agree to indemnify, defend, and hold harmless Dagostino Enterprise, its officers, directors, employees, contractors, and agents from and against any claims, liabilities, damages, losses, and expenses, including reasonable attorneys' fees, arising out of or in any way connected with: your access to or use of the Platform; your violation of these Terms; your violation of any applicable law or regulation; or your infringement of any third-party rights.

## 15. Dispute Resolution

---

### 15.1 Governing Law

These Terms shall be governed by and construed in accordance with the laws of the State of Wyoming, without regard to its conflict of law provisions.

### 15.2 Arbitration

Any dispute, claim, or controversy arising out of or relating to these Terms or the Platform shall be resolved by binding arbitration in accordance with the rules of the American Arbitration Association. The arbitration shall be conducted in the State of Wyoming. You waive any right to participate in a class action lawsuit or class-wide arbitration.

### 15.3 Exceptions

Either party may seek injunctive or other equitable relief in a court of competent jurisdiction to prevent irreparable harm pending arbitration.

## 16. Modifications to Terms

---

The Company reserves the right to modify these Terms at any time. Material changes will be communicated to users via email or prominent notice on the Platform no less than 14 days prior to the effective date of the change. Your continued use of the Platform following the effective date constitutes acceptance of the modified Terms. If you do not agree to the modified Terms, you must discontinue use of the Platform.

## 17. Termination

---

The Company reserves the right to suspend or terminate your account and access to the Platform at any time, with or without cause, and with or without notice. Upon termination for violation of these Terms, all prizes and entry fees associated with the account are forfeited. Upon termination without cause by the Company, unused entry fees for active contests will be refunded.

You may terminate your account at any time by contacting the Company at the address below. Termination does not relieve you of obligations incurred prior to termination.

## 18. Responsible Play

---

Statline Sports Club is intended to be an entertaining skill-based competition. The Company encourages responsible participation. If you believe your participation is negatively affecting your financial wellbeing, please contact us to discuss account limitations or voluntary self-exclusion options.

## 19. Severability

---

If any provision of these Terms is held to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect. The invalid provision shall be modified to the minimum extent necessary to make it enforceable.

## 20. Entire Agreement

---

These Terms, together with the Privacy Policy, constitute the entire agreement between you and the Company with respect to the Platform and supersede all prior agreements, understandings, and representations.
